\*Motorized Vehicles are not allowed to drive on the grass.

\*No glass containers are allowed

## THIS PERMIT IS FOR PICNICKING ONLY.

Entrepreneurial activities such as concerts, auctions, and garage sales are banned from all parks unless prior agreements, permits or variances have been granted by the City Council.

The Lessee will be responsible for leaving the shelter and surrounding grounds in a neat and clean condition. Failure to do so will result in loss of shelter reservation privileges and Lessee may be billed for clean up costs incurred by the city at a rate of \$10/hour.

Shelter reservations for the weekend must be made before noon on the proceeding Friday. Twenty four (24) hour notice is required on week days.
