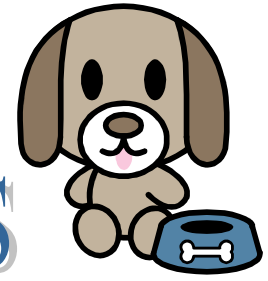


# ATTENTION ALL DOG OWNERS



**The American Falls City Code Title 6, Chapter 2, Section 1 states the requirements of Owners, City Clerk, Animal Control Officer and Policemen concerning dog(s) within the City Limits. A brief explanation of this Chapter is furnished for your information.**

An "Owner" is defined as any person keeping, harboring or maintaining a dog or dogs within the City Limits. A "Dog" is defined as to be either male or female. An "unlicensed dog" is any dog that is not bearing the current year City Dog License Tag.

Owners of dogs are required to purchase said licenses from the City Clerk or designated person, for such dog(s) by January first of each year, and such license is required to be placed upon the neck of each dog to display the compliance with such law.

Fees for Dog(s) are as follows:

License Purchased for Spayed or Neutered:  
(Documentation is required)

---in December	\$ 5.00
---in Calendar Year	\$10.00
---after Dog is picked up	\$20.00

License Purchased for Not Spayed or Neutered:  
(Or if no documentation available)

---in December	\$10.00
---in Calendar Year	\$20.00
---after Dog is picked up	\$40.00
Duplicate License	\$1.00

**Any dog up to three months old.....  
No license is required.**

Written citation for the violations of such laws can and will be issued by Policemen and the Animal Control Officer to the owner(s) in accordance to the laws.



Policemen and the Animal Control Officer are charged with the duty to seize and impound any dog(s) in violation of sections of this chapter. All dog(s) unlicensed will be held for a space of (72) hours during which an owner may redeem said dog(s) by purchase of License and payment of the following fees:

1. Pound fees shall be \$5.00 per day
2. Initial pickup- \$30.00
3. Second pickup of same dog within one (1) year- \$40.00
4. Third pickup of same dog within one (1) year- \$60.00

All licensed dog(s) shall be held for a space of (7) days during which as owner may redeem said dog(s) with payment of the pickup and pound fees. All dog(s) unclaimed may be sold or disposed of in a humane and lawful manner.

This Chapter states it is unlawful for an owner to keep, maintain or harbor any dog(s) that bark, howl, or yelp to the disturbance of the peace to any person(s) or neighborhood within the City Limits. It is unlawful to allow said dog(s) to run at large upon any public street, alley, sidewalk, way or place without a leash, and said leash cannot exceed (10) feet in length, or to run at large upon any private properties within the City Limits without expressed permission of owner(s) or tenant in possession of such properties. It is unlawful to keep harbor, or maintain more than (3) dogs upon the premises of any one household.

It shall be unlawful for any person(s) to molest, interfere or hinder with a Policeman or the Animal Control Officer in the seizing and impoundment of such dog(s)

It shall be unlawful for any person(s) to maltreat, torture, or injure any dog or having the right and authority to kill any dog(s) in an inhumane manner.
