To my surprise their respective leaderships said it was their first-ever joint meeting. Tournament schedules were discussed and penciled in as the two associations worked with new City Golf Pro Denny Howell and Superintendent Cody Moldenhauer. The interesting part of the meeting for me was the discussions on course improvements and memorials. The group came up with some great suggestions for the ways each could be implemented and funded. Those ideas will take association action by the women and men and then forwarded to the Golf Committee for implementation. But, as I explained to the group, the City has every intent and interest in working with them to make their great ideas reality. I would welcome the opportunity to speak to their respective groups or collectively to answer any questions they may have and take constructive feedback on how we can make golf in American Falls something that more folks want to do.

I do plan to fish today. I hope to find Pete and his friends somewhere on the river after I fulfill my other commitment. It is supposed to be perfect today with winds up to 30 mph and a 50 percent chance of rain, although the rain doesn't look likely. How unfortunate, I know, I am an odd duck. Then again, that was a forgone conclusion.
