Basically SCADA collects information from sensors and sends it to the system's programmable logic controllers, which then send that information to computers with SCADA software. The SCADA software analyzes and displays the data on a computer or smart phone. This automated reporting process helpsSuperintendent Pete Cortez, our Waste Water Treatment Plant Operator Scott Dallingand others in the department reduce wasted time and improve efficiency as they monitor and work within our water distribution systems and waste water collections. On a similar positive note, the new sewer line to the American Motel has been completed; another project checked off.

The Miller Lite, Red, White and Blue golf tournament was held this past weekend. It was the season's largest and last, with 78 players each playing 27 holes. It was successful by every measure and a great way to wrap up the regular tournament season. In the weeks and months to come the same may not hold true for the fish and water quality in American Falls reservoir and the river below as the reservoir dipped to ten percent last week. In a note I received from Lynn Van Avery with the Idaho Department of Environmental Quality he stated that there is a pretty good algae bloom going on, but that sediments and sedimentation are not an issue yet. As water continues to empty from the reservoir and the winds of fall grow near, sedimentation may once again become an issue and concern for the health of the local ecosystem.

The Chief District Judge for the United States District Court for the District of Idaho, B. Lynn Winmill, recently ruled that the 2014 Ag Gag Law violates the First and Fourteenth Amendments, and therefore the heart of the law is unconstitutional. Judge Winmill's ruling will no doubt cause concern for many Idaho agricultural operations but it provided a once in a lifetime learning opportunity for the seven members of the National qualifying American Falls FFA Agricultural Issues team. As you may recall, the team's issue this year presented both sides of the Ag Gag Law. Three members of the team represent animal rights and investigative journalists while three others represent the State of Idaho and proponents of the law and its original legislation. The seventh member of the team actually portrays Judge Winmill. Upon the Judge's ruling last month I contacted him to see if he would be willing to sit down with the team to discuss the case and provide input based on their presentation in preparation for the national competition next month. Last Tuesday, Judge Winmill spent two hours doing just that as he made the trip to American Falls High School. It was gratifying to me to see the back and forth discussion, questions and answers from both the Judge and the students. Honestly, I am not sure who was more impressed, the Judge or the students. What I can tell you is that the one-on-one and back and forth on a topic the students have spent nearly a year researching was an invaluable learning experience and one I could have never duplicated in the "regular" classroom.

Judge Winmill's ruling on Idaho's Ag Gag Lawwill most likely be appealed by the State and move up the legal system. I am certainly no legal scholar, but based on the research done by my students, and the discussion and points made by Judge Winmill, I bet his decision will be upheld. As to the Ag Issues team, they have a foundation and understanding of the issue that will allow them to compete exceedingly well if as a group they now make the commitment to do what is necessary to compete at the very highest of levels. I hope they choose to deviate from their weekly routines and make the time to prepare for what will be a very competitive national event. Should that commitment be made, the National Ag Issues event may well serve as a stepping stone to many more life changing possibilities for each of them.
