Marsha Rensch stated that she enjoys living in the town because she does not want to deal with live stock.

AN ORDINANCE OF THE CITY OF AMERICAN FALLS, IDAHO, AMENDING ORDINANCE NO. 642, THE APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2020 AND ENDING SEPTEMBER 30, 2021; TRANSFERING MONIES FROM ONE FUND TO ANOTHER AND APPROPRIATING ADDITIONAL MONIES TO BE RECEIVED BY THE CITY OF AMERICAN FALLS, IDAHO IN THE SUM OF \$202,465.56. AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR, AND THE CITY COUNCIL OF THE CITY OF AMERICAN FALLS, POWER COUNTY, IDAHO, AS FOLLOWS:
