 - a. Any alcohol waivers require signed consent of either Mayor or Chief of Police.
2. Curfew—Parks closed to public from 11 p.m. to 6 a.m. except by permit.
(Family or Organiz. permit issued by City Clerk) (Community Event permit issued by City Clerk with Council approval)
3. Motorized vehicles not allowed to drive or park on the grass without prior approval.
4. No Glass containers allowed. ----- Pets must be on a leash.
5. Cleaning Deposit will be returned **BY REQUEST ONLY** within 60 days.
6. Please no smoking in shelters, bathrooms, or around playground equipment.

THIS PERMIT IS FOR PICNICKING ONLY.

Commercial activities such as concerts, auctions, and garage sales are banned from all parks unless agreements, permits, or variances have been granted by the City Council.

The Lessee will be responsible for leaving the shelter and surrounding grounds in a neat and clean condition. Failure to do so will result in loss of shelter deposit, shelter reservation privileges, and the Lessee may be billed for clean-up costs incurred by the City at a rate of \$20/hour.

Shelter Reservation for the weekend must be made before noon on the preceding Friday. Twenty-four (24) hour notice is required on weekdays.
