SANITATION RATE SCHEDULE

A RESOLUTION OF THE CITY OF AMERICAN FALLS, IDAHO, A MUNICIPAL CORPORATION, ESTABLISHING A SCHEDULE OF RATES, FEES AND CHARGES FOR SANITATION IN ACCORDANCE WITH SECTION 8-1-8 OF TITLE VIII OF THE MUNICIPAL CODE OF THE CITY OF AMERICAN FALLS.

WHEREAS, the City of American Falls has adopted the Public Service Ordinance #414, which provides that the rates, and charges for sanitation be set by Resolution; and

WHEREAS, the City of American Falls finds it necessary to adjust the sanitation fees due to the additional costs of administration, operations, and maintenance of this program;

NOW, THEREFORE BE IT RESOLVED by the Mayor and City Council of American Falls, Idaho, that the following sanitation rates be established, effective October 1, 2022;

- (A) Residential: For each single family unit, the sum of six dollars (\$8.00) per month. A single family unit is each housekeeping unit. Residential pickup shall be done once each week on a day designated by the City.
- (B) Commercial: For service to retail and wholesale businesses, hospitals, nursing home, restaurants, motels, service stations, offices, banks, residential rental complexes of twenty

(20) or more units, other commercial businesses and shall be according to the following table.

The Street/Sanitation Superintendent, in establishing the number of containers and the number of pickups per commercial establishment, shall take into consideration the quantity of refuse likely to be deposited in the container and the number of users that propose to use the container. The Street/Sanitation Superintendent is empowered to add to or subtract from the containers originally provided, as the need dictates.

(C) For any pickup not expressly provided herein, the rate shall be fixed by resolution of the City.
