### **RESOLUTION #609A SEWER RATE SCHEDULE**

**A RESOLUTION OF THE CITY OF AMERICAN FALLS, IDAHO, A MUNICIPAL CORPORATION, ESTABLISHING A SCHEDULE OF RATES, FEES, AND CHARGES FOR SEWER AND SERVICE IN ACCORDANCE WITH SECTION 8-1-8 OF TITLE VIII OF THE MUNICIPAL CODE OF THE CITY OF AMERICAN FALLS.**

**WHEREAS**, the City of American Falls has adopted the Public Services Ordinance #515, which provides that the rates, fees, and charges for sewer and service be set by Resolution.

**BE IT RESOLVED** that in accordance with section 8-1-8 of Chapter 8, of Title VIII of the Municipal Code of the City of American Falls, as amended, the following monthly rates be charged to the hereinafter listed sewer users for sewer and service as provided by the Municipal Sewer System of said City to become effective October 1, 2023:

The base sewer rate or unit to be charged: \$ 62.00

The base sewer rate shall be multiplied by the Equivalent User as specified in 8-3-18.

## **SEWER CONNECTION FEE**

4" Sewer Hookup \$ 1,500.00

- Includes a \$70.00 Sewer Saddle Fee; a \$ 5.00 Permit Fee and a \$ 10.00 Inspection Fee.
- Sewer Saddles are provided by the City of American Falls.
- The sewer saddle fee may be waived if the Building Administrator determines that a sewer saddle is not necessary.
- Replacement of an existing sewer hookup \$85.00
- The hookup fee for larger than a 4" line will be based on the Equivalent User Chart.

**SEWER MAIN CONSTRUCTION FEE** - \$20.00 per lineal foot of property being served.
